



## APPLICATION FOR SOLICITORS / MOBILE VENDOR'S LICENSE

(Check which license you are applying for)

- One Day Solicitor's License Fee \$35.00**
- One Year Solicitor's License Fee \$170.00**  
(Expires yearly on June 30)

- Each individual solicitor must apply for own solicitor's license.
- Application for a solicitor/mobile vendor license must be made at least two working days before the license may be issued.
- You will not be issued a license if you have been convicted of a felony within the past 10 years, or a misdemeanor within the past five years (Background checks will be run before license is approved).
- You are required to carry and display the solicitor or mobile vendor license whenever engaged in solicitation or mobile vending.
- Non-refundable fee must accompany application.

### VIOLATIONS OF SOLICITOR'S LICENSE

- A. Parking regulations as contained in Titles 10 and 12.12 of the Enumclaw Municipal Code, as amended;
- B. Shall not obstruct the passage along any sidewalk, street, alley or parking lot by causing a congregation of people, nor create a hazard to the public health of safety, nor create a nuisance as evidenced by complaints from the public;
- C. Mobile vendors shall not remain in any one block for more than one hour;
- D. Mobile vendors shall not sell within four hundred feet of any school grounds during school session or events, except if vendor possesses written permission from the school involved;
- E. Shall comply with all clauses and regulations of the King County Health Department regarding food handling;
- F. Shall not misrepresent facts to the city license officer or to the public.
- G. Shall not engage in soliciting any time other than a standard working day.
- H. Shall not engage in soliciting or mobile vending in any area of the city other than areas which are classified by the city's zoning code as follows:
  - NB Neighborhood Business
  - CB1 Central Business
  - CB2 Central Business
  - HCB Highway Community Business
  - GO General Office
  - LI Light Industrial
 (These areas are outlined on the map provided)

#### Ice Cream Mobile Vending (in addition to above information)

- A. Ice-cream mobile vending shall only occur during the days of the year from the beginning of April through the end of October;
- B. Ice-cream mobile vending shall only occur on Monday through Saturday, between 8:00 a.m. and 8:30 p.m.;
- C. Only ice-cream vendors are permitted in all city zones (as outlined above).
